- ENTRY FEES:** \$65.00 per dog – electronic catalogue will be available prior to the trial
- ONLINE ENTRIES:** via Top Dog Events
- ENTRIES CLOSE:** MONDAY 10TH AUGUST 2026 - NO LATE ENTRIES will be accepted.
- VETTING:** 07.30 -8.00 am START: As soon as practicable after the conclusion of vetting
- PUBLIC DRAW:** will be held the at the conclusion of the Linc Sullivan Memorial Cup conducted by the Retrieving Club of WA. on Saturday 15th August 2026.
- ELIGIBILITY:** A Championship Stake is confined to Gundogs that have been placed first in a Restricted Stake or first, second or third in an All Age Stake or have the title All Age Retrieving Dog (AARD). Proof of Eligibility must be included with the entry for a non-titled dog.

CONDITIONS OF ENTRY

ALL COMPETITORS MUST HAVE:

- A current Dogs West membership card or Dogs Australia member body equivalent.
- A Dogs West indemnity card (or sign a Dogs West Firearms Indemnity Form) or a valid Firearms Licence (or a copy of a Corporate Licence, if applicable) whilst handling a gun.
- BITCHES IN OESTRUM shall not be permitted to compete but may be on the property but not in the vicinity of the Trial Site or the area of Runs.

- **LEADS:** Except when competing or in the designated exercise area, dogs must be kept on leads, securely held or tethered. Note: No dogs allowed in the gallery.
- **JUDGES:** Dogs West reserves the right to change the Judge should it become necessary
- **TRIAL VENUES:** Are private properties and are used with the kind permission of the owners. They must not be revisited at any time, nor should the owner be approached regarding access without the prior permission of the property nominee. Please respect the properties by picking up your litter, keeping to designated areas and leaving all gates as you find them.
