Gradings: Conformation - GSDCA gradings will be awarded at the judge's discretion: Promising and very promising in baby, minor and puppy classes. Good and very good to animals over 12mths in junior, intermediate and open classes. The grading of excellent and the medallion will only be awarded to exhibits two years of age or over, entered in the open classes and classified Cl.1 or Cl.11 under the GSDCA breed survey scheme (or other GSDCA approved scheme)

Critiques: Minor, puppy, junior, intermediate and open classes. Critiques/gradings are the property of the GSDCV Inc and will be published on the following websites www.gsdcv.org.au and www.gsdcouncilaustralia.org
