- Despite requests clubs are not advising the dates for their active days for training/handling classes etc. Failure to do so means that they are not covered by the Public Liability Insurance Policy the TCA Inc holds on their behalf and place the club and committee members at risk if there is a situation that leads to a claim being lodged.
- Exhibitors at TCA Inc sanctioned conformation fixtures are to be surveyed relating to Regulations 33, 33A and 127.1. A notice will be published in the February/March issue of the Gazette and the questionnaire that was circulated at the last Council meeting will be placed on the website, distributed at shows and be available from the TCA Inc office for exhibitors to complete.
