## AGE CLASSIFICATIONS FOR ENTERING SHOWS

Age Classifications are set out below and are effective for all Exhibitions.

Dogs	Bitches	
1 Baby Puppy	3 months and under 6 months	1A
2 Minor Puppy	6 months and under 9 months	2A
3 Puppy	6 months and under 12 months	3A
4 Junior	9 months and under 18 months	4A
5 Intermediate	18 months and under 36 months	5A
9 State Bred	6 months and over whelped in S.A.	9A
10 Australian Bred	6 months and over	10A
11 Open	6 months and over	11A

**FURTHERMORE,** due to confusion sometimes arising over the correct calculation of a dog's age into breed classes where the date of birth does not occur in the relevant month, the anniversary date is to be taken as the last date of that month, *e.g. dogs born on 31st January will be eligible to enter the Baby Puppy class on the 30th April.*
