## ENTERING A DOG IN A SHOW OR TRIAL

It is very important that all members ensure their Dogs NSW Membership remains financial.

If your membership, or the membership of any person who is indicated on the certificate of registration as being the 'registered owner/s' of a dog, reverts to un-financial or they are not a member, Dogs NSW Regulations, Part II – Show, 1.10, 12.2 and 14.3 will have the effect of disqualifying the dog from all awards attained whilst any one of its registered owners were not a financial member of Dogs NSW or of another ANKC Member Body.

Any person who handles a dog at an approved Show must also hold a current financial membership.
