**Check in Time:** Trial one (both days) 8.30 - 9am, trial two (both days) 11.30am - 12 noon. Rally walk through 10 minutes prior to starting time

**Judging Time:** Trial one 9.30am, trial two 45 minutes after completion of judging of trial one but not before 12.30pm

**Catering:** Available

**Awards:** Obedience - cash and sash for first place. Ribbons to second and third. Qualifying cards and ribbons/title sashes. Highest score in trial - prize and sash. CCD not eligible for highest scoring obedience awards. Rally - cash and rosette to first place, ribbons to second and third. Qualifying cards and ribbons. Title rosette
