NOTE: No person over the age of 18 years who is a resident of Victoria can exhibit, handle, officiate in the judging ring, or register an animal with the Victorian Canine Association unless he or she is a financial member of the Victorian Canine Association.

Entry fees: First entry \$25.00 (includes catalogue), subsequent entries \$10.00. Special classes \$5.00; De-sexed exhibits class \$7.00 if only entry. Entries will not be accepted without fees. Membership \$25 single, \$30 dual. Please state on entry if membership is desired.

Judging: will commence promptly at 10 am. Special classes will be judged after General Specials.
 Note judging order: 1, 2, 3, 4, 5, 10, 14, 11 & 12 - dogs
 1a, 2a, 3a, 4a, 5a, 10a, 14a, 11a & 12a - bitches

NOTE: **Baby puppies** are only eligible to compete in Baby Puppy classes, i.e. they cannot compete in the Challenge line up or in the Special classes.

New Class: Class 14 & 14a: Bred by Exhibitor. 6 months and over, the exhibit must be owned and handled by the breeder on record.

Special classes:

- 13 Brace** For two dogs six months of age or over, each of which has competed in at least one class at the same exhibition and is the property of the same owner and is handled in the judging ring by the one person.
- 15 Team** For three or more exhibits six months of age or over, each of which has competed in at least one ordinary class, is the property of the same owner and is handled in the judging ring by the same person.
- 19 Interstate Bred**
- 23 De-sexed exhibits class**
- 24 Parent / Progeny** (maximum of four (4) progeny)
- 26 Best Headed**
- 27 Best Gaited**
