



Currently The Adelaide Lure Coursing & Racing Club Inc. is the only club holding ANKC Lure Coursing trials and are supporting the canine sport of Lure Coursing in South Australia. The club has been running regular trials from the start of the passing of lure coursing in the ANKC and generally in the season hold them on a monthly basis except for the summer months.

Adelaide Lure Coursing & Racing Club Inc. established 8 official ANKC Lure coursing trials and 2 training and fun days for 2018.

Unfortunately due to hot weather the heat restrictions for the safety of the dogs came into effect for the 8th April and the trial had to be cancelled.

In support of lure coursing for the health of the dogs the ALCRC have also gained new sponsorship in 2018 with Noah's Crossing Hydrotherapy Centre. As part of the sponsorship an information seminar was held on 11th March, 2018 to provide a highly qualified presentation on conditioning and mobility concerns for highly active dogs. Within the talk it addressed areas of concern and correct conditioning using hydrotherapy.

To also help bring new interest and encourage dogs to try them on the lure the ALCRC participate with other canine clubs over Australia in a Non-Official fun day of sprint racing. The 100 metre sprint race "Battle of the States" will be held on 14th July and although not under the ANKC Banner does encourage many new prospects into the sport as all breeds are encouraged to race against the clock. It is a short run and once owners witness the thrill of chasing after a lure, many of them become interested in finding out more about official lure coursing trials.

The Adelaide Lure coursing & Racing Club Inc. currently have 47 financial members and slowly are gaining more support over time. In South Australia the sport is only successful from the support of all breeds and until they get a better backing from sighthounds it would not survive.

As to date with the current lure coursing rules in place achieving titles is a long process, in South Australia we have only 2 Sighthounds that have gained Single Field Champion Titles and 3 others breeds gaining their Coursing Ability Title, all of which have been trialling since the sport was passed by the ANKC (over 2 ½ years).

At present we have one person (Adrianna Matusicova) currently involved in the Lure Coursing training program and is being mentored in all the facets and positions required in the sport from here!
