**Prizes** – 1<sup>st</sup> place qualifying in each height category in each class. Rosettes for all qualifiers

Other Awards – Top Novice Jumping Dog, Top Novice Agility Dog (taken for the 5 agility trials) donated by Riverland Flight Training
