All exhibitors must abide by the COVID Safety Plan that has been agreed with the ACT Government to allow these shows to be conducted.

CONDITIONS OF ENTRY

- If you have even mild symptoms, **please stay away** and get tested.
- Exhibitors must enter the grounds via Old Well Station Road off the Federal Highway. There are a limited number of disabled car parks close to the upper entry.
- Attendees are encouraged to have downloaded the COVIDsafe app at https://www.health.gov.au/resources/apps-and-tools/covidsafe-app
- Whilst entries are open to all States, entries will not be accepted from any current 'Hot Spot' as
 indicated by State Government advice or from a high risk category as per the current ACT
 Government advice at https://www.covid19.act.gov.au/home
- Online entries only via Show Manager and will require acceptance of terms laid out in the COViD19 page to enable attendee tracking.
- All persons who are not officials or exhibitors must register their attendance at the office.
- Only exhibitors entered for the show and their immediate family may attend. Spectators are not permitted.
- There will be no paper catalogues issued at this event.
- The Catalogues will be available online prior to the event.
- Lapel card numbers will be emailed to exhibitors prior to the event and can be picked up on the day. It shall be the exhibitor's responsibility to print their own exhibitor numbers.
- Gazebos must be spaced a minimum of 1.5 metres apart.
- Only members of the same household can share a gazebo.

PHYSICAL DISTANCING AND HYGIENE

- There shall be no congregating or setting up in walkways or under ring awnings.
- Keep a distance of 1.5 meters between family groups.
- Practice good hygiene at all times.
- No person shall encroach on the Steward's safety zone (1.5 metres)
- Hand sanitizer will be available; however exhibitors are encouraged to bring their own.
- The wearing of masks is encouraged, but not mandatory.
- Exhibitors shall enter the building via the designated entrance and depart via the designated exit, maintaining physical distancing at all times.
- Exhibitors shall enter the show ring via the entrance and depart via the ring exit, maintaining physical distancing at all times
- Ring equipment shall be regularly sanitised during the event.
- Cleaners will regularly maintain hygiene conditions in the restrooms.
- Exhibitors are requested to maintain appropriate hygiene and physical distancing when visiting restrooms.
